Missed this year at registration was our dear friend Janice Jones who along with Larry, always greeted all attendees, and made it a point to really welcome new attendees.


Joe made the name tags and all but two were picked up, which means almost everyone who registered got a chance to attend.

TSNA 2019 Banquet Speaker

Our 2019 TSNA Reunion Banquet speaker told us about “a journey that changed my life.”

Stephanie Hanson Caisse was adopted as a baby, and knew nothing about her birth parents. But as an adult she began a search for her biological parents. In her Banquet address to the members of TSNA, she said that she did not realize where her search would take her. It brought her in contact with thousands of Marines and their families, including those who died in that helicopter crash in Vietnam with her Father.

One of the first things that Caisse learned was that her father, Gary Norman Young, died in a helicopter crash in Vietnam on 7 February 1969 ... two and one-half months before she was born. As a Navy Corpsman, he was accompanying Marines on a mission and was killed when the chopper went down. It was his first day of flying with the Marines.

But that was not the end of Caisse’s search.

She said she received thousands of letters of encouragement during her research time, which she said “helped me more than you will ever know.” She said she was genuinely “touched by the letters” which she received. The letters, she said, “showed emotions to a stranger.”

Her Dad, she said, “was a hero.”

Caisse said that her research pieced together what had happened to everyone aboard that chopper on that fateful 1969 February day. And, she said, her research “helped many other” families who lost a loved one in that crash.

In 1998, Caisse began her attempt to get her father’s Wings and other military medals. She was assisted by the current adjutant of the Purple Foxes, her Dad’s HMM 364 Unit. And eventually her request was approved ... 33 years after her Father lost his life in Vietnam.

Besides finding out about her father, what else did Cassie learn from her research? She learned that “by sharing stories, loved ones are not forgotten.” She learned that those who served in Vietnam “are among the nation’s finest.” She learned about the “kindness of strangers.”

She said that the legacy her Father left for her was to “speak for them,” that is, those who cannot speak for themselves.

Caisse closed by thanking the TSNA members for inviting her to speak at the Banquet and said, “Welcome Home.”

2019 TSNA Awards

The Tan Son Nhut Association at its 2019 Reunion presented awards in three of four possible categories to some very deserving members of our Association and to other persons or organizations which have been supportive of veterans over the years. We bestowed the Golden Knight and Anchor Award and inducted three members into the Military Order of the Dragon.

The Golden Knight Award was presented to a business in South Carolina well known in Myrtle Beach for nearly 10 years of support of veteran's needs and ideals. The business is well known for the veteran memorabilia on its walls and for a museum devoted to veterans. The business' owners also support fund raising activities devoted to veterans and supported Veterans during Hurricane Florence one year ago. The Veterans Café and Grille in Myrtle Beach is operated by Lou and Rhonda Mascherino, and they define the term "pillars of the community". George Bontya, a resident of the Myrtle Beach area and patron of the cafe, received the award to present on behalf of TSNA to the Mascherinos.

Before TSNA was chartered as a non-profit corporation in the Commonwealth of Virginia, it was such a corporation in the State of Wisconsin. Under Wisconsin law, there had to be a registered agent who was a resident of the state. To comply with that law, the Board asked one of our Life Members who is a resident of Wisconsin to fulfill the duty. That member agreed and helped us for three years. So, for his help and assistance, we presented the Anchor Award to Richard Lindbeck.

If it were not for the work on the TSNA Scholarship Committee by the three Dragon inductees, the Scholarship Program would not be the success it has become.

The first Dragon inductee has been on the Board of Directors for three years and has just been reelected to a second term. He has been a fixture at many reunions, always pitching in behind the scenes to make each a success. He earned a college degree while on active duty as an Air Force NCO and was then commissioned as an Air Force officer. It made him an ideal person to serve on the TSNA Scholarship Committee. Jim Faulkner, Director at Large, was inducted into the Tan Son Nhut Association Military Order of the Dragon.

The second Dragon inductee's contribution to TSNA has been completely behind the scenes. Were it not for the service of this Dragon inductee, our TSNA Scholarship Program would not be what it is today. He was asked to serve on the Scholarship Committee because he pursued a college education after being honorably discharged from the Air Force. In his community, he has been very active in an organization of veteran business persons and makes many significant contributions to it. We rely on Hugh Penn to help select a student worthy of receiving a TSNA scholarship from a list of very qualified candidates.

The Scholarship Committee must review many documents. Among these may be one written in Vietnamese because members of the South Vietnamese military are eligible to apply for the scholarship. When a person was identified and asked to serve on the committee, she modestly considered herself not qualified. But with some prodding, she did agree to serve. And her contributions to the Scholarship Committee are many since becoming a member. Susie Ahrens was inducted into the Tan Son Nhut Association Military Order of the Dragon.

Board and Membership Meetings

Saturday at the reunion was a day for administration. The annual meeting of the TSNA Board of Directors was conducted during the afternoon, and the general membership meeting occurred during the evening.

As usual, the board meeting was mostly routine to catch up on administrative tasks.

President Randall Brown mentioned that we are conducting the 21st reunion of our association. Also, during his opening comments, he stated that our scholarship is a trust for the future that could live on even after our association ceases to be the active organization it is today. He also directed the Vice President and Secretary to draft a Bereavement Policy document.

Treasurer Andy Csordas reported that we are financially sound and may continue to dedicate memorials at future meetings and place wreaths on veteran holidays at The Wall in Washington, DC and our memorial bench at the Air Force Museum at Wright-Patterson AFB. The Scholarship Fund is flush enough to award two in 2020. The board approved a fund of \$2,000.00 for the Director of Reunion Planning to use in underwriting his activities that make our reunions such a success. Three possible locations for the 2020 reunion will be researched by the director.

BX sales this year are slightly down from previous years.

There are no issues related to either the web site or Revetments. Those entities are important, because to many members they are their connection with our association.

At the membership meeting, there was an update by the Scholarship Committee Chair, and he reported that we will award two in 2020. All recipients are excelling in their studies.

It was announced that the five board members who ran unopposed for continuing in office were unanimously reelected. They were then sworn in by Chaplain Jimmy Smith.

The potential sites for the 2020 reunion are Buffalo/Niagara, NY; Gettysburg, PA; and Williamsburg, VA. Final decision will be made in early 2020.

A banner that will hang over or on the front of tables for the silent auction was dedicated. See Paul Mortensen's article for details.

All-in-all, it has been a very good year for our association.
